Marlene Thomas called the meeting to order at 2:30pm.

Minutes from March and April 2021 meetings were approved as distributed.

TFN'S FY22 NOFA application was submitted Thursday, April 8, 2021 as follows. Nancy provided a revised budget to the state showing the reinstated funds (\$26,013) going to Conversations on Race.

As directed during the April meeting, the Services Review Committee to consider options for reallocation of what was the Mentoring Children of Incarcerated Parents funding. The group held two meetings. Based on a review of community survey and annual data and from the group's consideration, the following use of funds is recommended:

• Post COVID-19 Planning Grant \$19,000

Career Pathways / Opportunity Youth Navigator – Liaison \$42,048

It was moved and approved that this change be implemented. All in favor. None opposed. Nancy will notify the state of this change for FY22. An RFP will need to be issued for the Career Pathways funds.

Executive Director's report – written report provided. Nancy spotlighted the FY21 reallocation of funds totaling \$5,500 as approved by the Executive Committee and subsequently submitted to the state. She asked for consideration of this additional change:

Reduce the COVID-19 Relief budget by \$1,800 due to decrease in emergency need for food at area food
pantries. Move those funds to the Mental Health program, Stress Relief for Parents and Caregivers due to
COVID-19. With this change, an additional 20 individuals can be served. A motion was made. All in favor.
None opposed.

Nominations – Catherine Poe retires off the Board on June 30, 2021. Derick Daly and Matthew Peters have both respectfully declined invitations to join the Board. The list of suggested Board candidates was reviewed again. It was agreed that Jazmine will reach out to Berenice Orellana with an invitation to join the TFN Board. It was moved and approved that if she accepts her name will be forwarded to the County Council for appointment, and if not, the Nominations Committee is empowered to pursue other prospects on the list and finalize a candidate. All in favor. None opposed.

Meeting was adjourned at 2:55 pm.
