**MEETING MINUTES**

Minutes of the January 20, 2026 meeting. Motion by Lauren Weber. Second by Katie Fox. All in favor; none opposed. No abstentions.

**FY26 COMMUNITY PARTNERSHIP AGREEMENT**

Nancy Andrew deferred on a FY26 budget modification request awaiting information from current program vendors about their budgets.

Mid-year reporting to TFN is complete for 6 of 7 vendors. For TFN’s mid-year reporting to the Governor’s Office for Children (GOC), 2 of 3 requirements complete. Scorecard reporting on all program performance measures should be completed this week. GOC shifted full Scorecard reporting maintenance to the LMBs this year; as a local maintainer, TFN must absorb the added time and effort.

**FY26 MSDE HEALTHY FAMILIES FUNDING**

MSDE changed FY26 Healthy Families eligibility so only LMBs could apply; TFN learned of this abruptly last FY and partnered with TCHD to submit the application, with TFN now administering the funds. Nancy is learning MSDE reporting requirements (a significant lift) amid unresponsive MSDE grant staff; TFN has not yet requested reimbursement for any TCHD expenses, and a budget modification submitted in late November was approved this month.

**FY27 COMMUNITY PARTNERSHIP AGREEMENT**

The GOC released the FY27 Notice of Funding Available in late January with applications due on April 24, 2026.

**COLLECTIVE IMPACT TALBOT** - Other local initiatives / levers impacting poverty:

Board members shared updates on other initiatives, legislative news and community resources.
